The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is:

ARTICLE II.

ARTICLE III.

The general purpose of this corporation is to train girls ages 10-18 to be graceful and productive young ladies within their communities by:

- A. Providing them with productive community activity.
- B. Encouraging them to incorporate positive tools such as talking and listening to resolve conflicts.
- C. Helping them to understand that illegal drugs, alcohol, and sex is not the answer to life's troubles.
- D. Promoting school attendance and involvement in school extra-curricular activities to avoid obtaining a delinquency record.
- E. Planning special activities with the girls that promote their overall development of healthy, productive and fulfilling lives.
- F. And to transact any or all lawful business for which corporations may be incorporated under Chapter 607 and 617, Florida Statutes.

ARTICLE IV.

Directors shall be elected or appointed in the manner and for the terms provided in the in the bylaws. The board of directors shall consist of not less than seven (7) persons.
