**ARTICLE I NAME:**

The name of this corporation shall be:

Solid Rock Christian Fellowship of Florahome, Inc.

**ARTICLE II PRINCIPAL OFFICE:**

**ARTICLE III PURPOSE:**

The purpose for which the corporation is organized is:

This corporation is organized for the purpose of worshipping the Lord Jesus Christ and ministering to the community of Florahome, FL and the surrounding areas. This will be accomplished through regular worship services, acts of benevolence to needy individuals and families, encouraging the saints of Jesus Christ in their Christian fellowship, and by evangelizing those who have not accepted Jesus Christ as personal Lord and Savior by proclaiming the Gospel contained in God's Word, the Holy Bible.

**ARTICLE IV MANNER OF ELECTION:**

The manner in which directors are elected:

Directors of this corporation are elected for an indefinite period. Should a vacancy occur due to death, resignation, or by recommendation from President and a majority vote of corporate officers the President of the corporation shall nominate a candidate to fill said vacancy and the candidate shall be confirmed by a majority vote of remaining corporate officers. Should nominated candidate not receive a majority vote of confirmation and all attempts at confirmation fail, then the President shall continue to present candidates until confirmation is made.

**ARTICLE V LIABILITIES OF OFFICERS:**

The liability of corporate officers shall be:

Whereas the nature of the operation of this corporation involves varied individuals acting on behalf of the corporation in direct contact with the general public and, furthermore, whereas the officers and directors of this corporation serve on a voluntary basis, the corporation does assume full responsibility for all actions of persons acting on behalf of the corporation as long as such action is with full knowledge and approval of the corporation. Should such action be without full knowledge and approval of the corporation, said individual assumes their own personal liability.

Furthermore, all officers and directors are hereby released from any personal liability connected with the administration of their duties as corporate officers and directors. Corporate officers and directors shall in no way be held personally liable for the actions of anyone, other than themselves, who is connected with the corporation.

Officers and directors do hereby agree that the corporation shall maintain sufficient liability insurance as they deem necessary to protect the corporation should such liability claims arise.
