The undersigned hereby establishes the following for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges, and immunities of a Corporation **not for profit**.

**Article 1
Name of Corporation**

The name of this Corporation shall be The Haitian Church of Christ of Lake Worth Inc.

**Article 11
Principal Office**

The Principal Office of business is 930 South 'M' Street, Lake Worth, Fl. 33460.

**Article 111
Purpose**

The general purpose of this corporation is to establish and to maintain a church designated The Haitian Church of Christ of Lake Worth Inc. to provide a place of public worship for its members, to provide religious instructions and teaching, to further other religious and charitable work and to acquire, hold, manage, maintain, lease, mortgage and dispose of property, real and personal, of said corporation.

**Article IV
Membership**

All members in good standing of The Haitian Church of Christ shall be members of this corporation.

Article V
Corporation duration

This corporation shall have perpetual duration unless sooner dissolve by law.

Article VI
Initial Officers/Directors

The names of the Officers and Directors of this corporation shall be members in good standing of said corporation. These officers so designated shall be subject to the authority of the members of said church and will be responsible for managing the affairs of the corporation. The officers shall be elected by a majority vote of members of the corporation, in good standing, present at the general meeting of the corporation which shall be held annually and in the month of January of each consecutive year, the date and time shall be determined by the serving officers. The officers of the corporation shall be removed from office, or be added by a majority vote of members of the church in good standing. 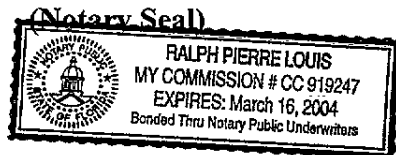
