

**ARTICLES OF INCORPORATION**  
**OF**  
**ALPHA POINT OUTREACH, INC.**

The undersigned, acting as sole incorporator, does hereby desire to form a not for profit corporation pursuant to the Florida Not For Profit Corporation Act and does hereby adopt the following Articles of Incorporation:

**Article I - Name of Corporation**

The name of the corporation shall be ALPHA POINT OUTREACH, INC.

**Article II - Term of Existence**

The corporation shall commence its corporate existence upon the execution of these Articles of Incorporation and shall exist perpetually.

**Article III - General Purpose**

The general purpose for which this corporation shall be organized shall be to engage in any lawful act not for pecuniary profit and not specifically prohibited to corporations under the Florida Not For Profit Corporation Act as may be, from time to time amended, or any other laws of the state of Florida. Such purposes include without limitation, charitable, benevolent, eleemosynary, educational, historical, civic, patriotic, political, religious, social, fraternal, literacy, cultural, athletic, scientific, evangelical outreach, agricultural, horticultural, animal husbandry and professional, commercial, industrial, or trade association purposes.

**Article IV - Registered Office; Mailing Address**

The location and mailing address of the corporation is 5325 Edgewater Dr., Orlando, FL 32810. The location of the principal office shall be subject to change as may be provided in the Bylaws duly adopted by the directors of the corporation.

**Article V - Directors**

The corporation shall have three (3) or more directors. The number of and method in which such directors shall be elected or appointed shall be provided in the Bylaws duly adopted by the directors of the corporation.

### Article VII- Dissolution

Upon the dissolution of the Corporation, assets shall be distributed for the exempt purpose(s), for which the corporation was formed, within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose which corresponds to the corporation's exempt purpose (s). Any such asset not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such exempt purpose (s) and to such charitable organization or organizations as are likely to utilize the remaining assets for said exempt purpose(s).

### Article VIII - Miscellaneous

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislations, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal taxation under 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX - Indemnification

The corporation shall indemnify its directors, officers, employees and agents to the full extent allowed by the Florida Not For Profit Corporation Act.
