ARTICLES OF AMENDMENT TO THE RESTATED AND AMENDED ARTICLES OF INCORPORATION OF ALCOHOPE OF THE TREASURE COAST, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Alcohope of the Treasure Coast, Inc., a Florida corporation, adopts the following Articles of Amendment to its Restated and Amended Articles of Incorporation:

ITEM ONE: The fifth paragraph of ARTICLE II is hereby deleted and substituted in lieu thereof shall be the following:

In the event this corporation elects to dissolve, as permitted by the Florida Statutes, all assets remaining in the corporation, after payment of its outstanding obligations, shall be distributed to such one or more organizations as are qualified to receive assets as the corporation or entity which is exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue law and to which a contribution would be deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ITEM TWO: This amendment to the Restated and Amended Articles of Incorporation was adopted unanimously by the Directors of the Corporation on September 8, 2009, in the manner prescribed by the Florida General Corporation Act:
