ARTICLES OF INCORPORATION OF FIRST HOUSING CROSSINGS, INC.

In compliance with the requirements of the Florida Not For Profit Corporation Act (Chapterte 617 of the Florida Statutes), the undersigned, being of full age certifies:

ARTICLE I

Corporate Name

The name of the corporation is First Housing Crossings, Inc. (hereinafter, the "Corporation").

ARTICLE II

Corporation Not For Profit

The Corporation is being incorporated as a corporation not for profit under the provisions of the laws of the State of Florida.

ARTICLE III

Principal Place of Business

ARTICLE IV
