ARTICLE I NAME

The name of the corporation shall be:

IGLESIA "ABRIGO DEL ALTISIMO", INC.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Iglesia "Abrigo del Altisimo," a New Testament church of the Lord Jesus Christ is a local body of baptized believers who are associated by covenant in the faith and fellowship of the gospel, observing the two ordinances of Christ, committed to his teachings, exercising the gifts, rights and privileges invested in them by his word, and seeking to extend the gospels to the ends of the earth. Iglesia "Abrigo del Altisimo" is an autonomous body, operating through democratic processes under the lordship of Jesus Christ. In such a congregation members are equally responsible. Its spiritual officers are pastors and deacons. The New Testament church speaks also of the church as the body of Christ, which includes all redeemed of all ages.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Each person named in the Articles of Incorporation as a member of the initial Board of Directors will hold office until his successor will have been qualified and elected by 2/3's at the first annual meeting of shareholders, or until said director's earlier resignation, removal from office, or death.

At the first annual meeting of shareholders and at each annual meeting thereafter, the shareholders will elect directors to hold office for a term for which he is elected until his successor will have been qualified and elected, his prior resignation, his removal from office or his death.

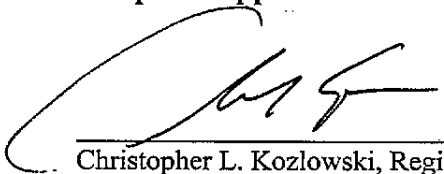

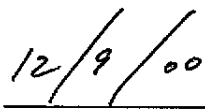

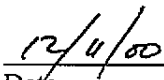
