## ARTICLES OF INCORPORATION

EFFECTIVE DATE

1-1-2001

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be: Bread of Heaven, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1300 17<sup>th</sup> Avenue West, Bradenton, FL 34205.

### ARTICLE III DURATION

The term of existence of the Corporation is perpetual and will commence ( JANUARY 1, 2001.

### ARTICLE IV PURPOSE (S)

The specific purpose(s) for which the corporation is organized are:

- To provide outreach services to youth and their families that espouse moral values through Christian practices, and hence, help them to develop as accepted members of the community;
- To offer training initiatives for youth and adults that nurture the development of life skills;
- To provide opportunities for youth to engage in meaningful projects to build their leadership capacity and create options;
- To help address the physical, social and economic needs of individuals living in abject poverty through feeding and clothing programs;
- To promote meaningful partnerships between the church, business and industry, and community leaders to support youth and adults in their pursuit to live independent and productive Christian lives.

### ARTICLE V MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are appointed is:

Directors are appointed based on their commitment to the organization's mission and purpose. Directors will not be compensated for their services. Directors will be appointed at the annual meeting and will serve terms in accordance with the adopted By-laws of the Corporation.

**ARTICLE VI  
CAPITAL STOCK**

The corporation is a not for profit under Chapter 617, Florida Statutes, shall have no capital stock and no director shall have any right or title to any asset of the corporation.

**ARTICLE VII  
EARNINGS**

No part of the earnings of the corporation shall inure to the benefit of the directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose stated above.

**ARTICLE VIII  
DISSOLUTION**

In the event of dissolution, and after all outstanding debts and claims have been satisfied the members shall distribute the property of the Corporation to such other organization or organizations maintaining a similar purpose and recognized as a 501(c) (3) of the Internal Revenue Service Code.
