ARTICLE ONE NAME AND PRINCIPAL PLACE OF BUSINESS

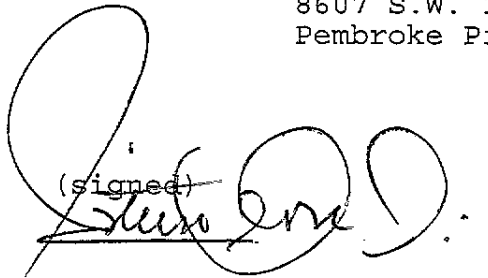

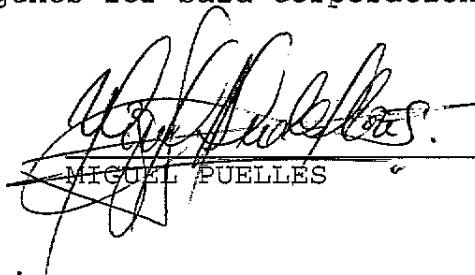
