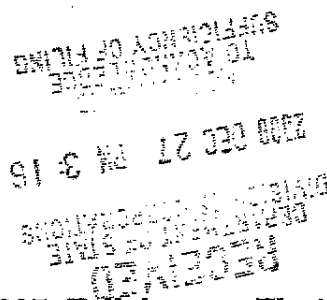

Pursuant to Florida Statute 617, et seq., I, the undersigned, subscribe to this document for the purpose of forming a non-profit corporation by and under the provisions and laws of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation not for profit.

FIRST:. The name of the corporation shall be: Fuentes en el desierto Messianic Jewish Biblical Ministry *Inc.*

SECOND: The corporation is organized for the purpose of operating a Messianic Jewish Biblical Ministry.

THIRD: The manner in which the directors are to be elected shall be provided for in the by-laws.


