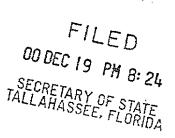

# ARTICLES OF INCORPORATION OF XI OMICRON OMEGA CHAPTER OF ALPHA KAPPA ALPHA SORORITY, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Law of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

#### Article I - Name of Corporation.

The name of this corporation shall be XI OMICRON OMEGA CHAPTER OF ALPHA KAPPA ALPHA SORORITY, INC..

### Article II - General Nature of Business.

The purpose of this corporation is to promote and further the interests of not for profit entertainment, education, and other lawful purposes.

#### Article III - Powers

The corporation shall have all of the statutory powers of a corporation not for profit.

#### Article IV - Members

The members of this corporation shall consist of the incorporators to these articles and such other persons as shall hereafter be determined by the members. The membership in the corporation shall continue until such time as the respective members specific terms expire. Each member shall be entitled to one vote, except that in the case of

a tie vote, the tie will be broken in the manner set forth in the By-Laws of the corporation.

#### Article V - Existence

This corporation shall exist perpetually unless dissolved according to law.

# Article VI - Registered Office and Registered Agent

The registered office of the corporation shall be at 36 Oak Avenue, Panama City, Florida 32401, and the registered agent at that address shall be Cecile M. Scoon.

#### Article VII - Number of Directors

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) persons, as shall be designated by the By-Laws and elected at the annual meeting.

#### **Article VII - First Board of Directors**
