ARTICLES OF INCORPORATION
OF
THE WHOLE ARMOUR OF GOD WORSHIP CENTER, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Law of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

Article I - Name of Corporation

The name of this corporation shall be THE WHOLE ARMOUR OF GOD WORSHIP CENTER, INC.

Article II - Address

The principal place of business and mailing address shall be 3508 St. Luke Street, Panama City, FL 32401.

Article III - General Nature of Business

The purpose of this corporation is to function as a church and to further the interests of Christian education, ministry and service .

Article IV - Powers

The corporation shall have all of the statutory powers of a corporation not for profit.

Article V - Members

The members of this corporation shall consist of the incorporators to these articles and such other persons as shall hereafter be determined by the members. The membership in the corporation shall continue until such time as the respective members' specific terms expire. Each member shall be entitled to one vote, except that in the case of a tie vote, the tie will be broken in the manner set forth in the By-Laws of the corporation.

Article VI - Existence

This corporation shall exist perpetually unless dissolved according to law.

Article VII - Registered Office and Registered Agent

The registered office of the corporation shall be at 3508 Luke Street, Panama City, Florida 32401, and the registered agent at that address shall be Ben Morning III.

Article VIII - Number of Directors

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) persons, as shall be designated by the By-Laws and elected at the annual meeting.

Article IV - First Board of Directors





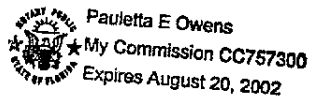
