

PLAN OF MERGER

The following plan of merger is submitted in compliance with section 617.1101. Florida Statutes, and in accordance with section 55A-11-01, North Carolina Statutes.

- 1. The name and jurisdiction of the <u>surviving</u> corporation is Discover Together Foundation, a North Carolina nonprofit corporation.
