



SCHEDULE OF AMENDMENTS TO THE ARTICLES OF INCORPORATION OF BLUE POINT CONDOMINIUM ASSOCIATION, INC.

1. 6.

6. All persons who own a vested present interest in fee to any unit in the condominium, which is evidenced by a proper instrument properly recorded in the Public Records of Collier County, Florida shall be members of the association, and upon termination of the association members at the time of the termination and their successors and assigns shall be members. Members' shares in the funds and assets of the association may not be assigned hypothecated, or transferred in any member except as an appurtenance to the unit for which the share is held. In all matters on which membership is entitled to vote, each member of the association unit shall have a one vote proportionate to his share in the common elements; as provided for, in the declaration of condominium and the association by-laws. The manner in which a vote is to be cast or exercised shall be determined by the declaration of condominium and the association by-laws.
