

## **Articles of Incorporation**

## **ARTICLE VIII**

The By-Laws of the corporation <u>may be altered</u>, <u>amended</u>, <u>or repealed in the manner provided in the By-Laws shall initially be made and adopted by its first Board of Administrators.</u>

Prior to the time of the property has been submitted to condominium ownership by the filing of the Declaration of Condominium, the By-Laws may be amended, altered, supplemented or modified by the membership at the annual meeting, or at a duly convened special meeting of the membership by a vote of unit owners entitled to exercise sixty-seven percent (67%) or more of the total voting power of the Association.

### Articles of Incorporation

### ARTICLE IX

Amendments to these Articles of Incorporation may be proposed by one-third (1/3) of the members or any three administrators and shall be adopted in the same manner as is provided for the amendments of the By-Laws set-forth in Article IX above. Said amendments shall be effective when a copy thereof, together with an attached certificate of its approval by the membership, sealed with the corporate seal, signed by the secretary or assistant secretary, and executed and acknowledged by the President or Vice President, has been filed with the Secretary of State, and all filing fees paid.
