ARTICLES OF DISSOLUTION

OF THE

Pursuant to the provisions of Section 617.1403 of the Florida Statutes (2002), the undersigned Florida not-for-profit corporation adopts the following Articles of Dissolution for the purpose of dissolving the Lani Kai Bay and Beach Condominium Association, Inc.:

ARTICLE I.

The name of the corporation (hereinafter called the Association) is the first Bay and Beach Condominium Association, Inc.

ARTICLE II.

Dissolution was authorized by unanimous vote of the Board of Directors on December 17, 2002 and by written Authorization of Sole Member of the Association, LKLB of Florida, Inc., a Florida corporation in conformance with Section 617.0701, Florida Statutes (2002).

RESOLUTION ADOPTING PLAN OF DISTRIBUTION AND AUTHORIZATION OF SOLE MEMBER

WHEREAS, the Directors of the Corporation wish to adopt the following Plan of Distribution of Assets of the Corporation and to memorialize their actions by this Resolution.

NOW THEREFORE, in consideration of the foregoing recitals, each of which is hereby incorporated in this Resolution as true and correct, it is hereby resolved as follows:

That Director Robert Conidaris, as President on behalf of the Corporation, is authorized to implement the following Plan of Distribution of the Assets of the Lani Kai Bay and Beach Condominium Association, Inc., effective the date of filing of the Articles of Dissolution for the Corporation:

- 1. All liabilities and obligations of the Corporation shall be paid and discharged, or adequate provisions be made therefor;
- Assets held by the Corporation upon conditions requiring return, transfer or conveyance, which such conditions occur by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
- 3. Assets received and held by the Corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a

condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving Corporation, as provided in this Plan of Distribution of Assets;

- 4. Other assets of the Corporation, if any, shall be distributed in accordance with the provisions of the Articles of Incorporation or the By-Laws of the Lani Kai Bay and Beach Condominium Association, Inc. to the extent that the Articles of Incorporation or the By-Laws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;
- 5. Remaining assets shall be distributed to LKLB of Florida, Inc., the Sole Member of the Corporation.

At the foregoing meeting, the undersigned Directors expressly and unanimously executed this Resolution Adopting Plan of Distribution and authorized Robert Conidaris, as President, to execute, authenticate and file this Plan of Distribution of Assets with the Department of State as an act of the Corporation.
