Articles of Incorporation

Article 1

Corporate Name

The name of the Corporation is **Harbinger Quest, Inc.**

Article 2

Purposes

The Corporation is a not-for-profit corporation. The Corporation is organized and shall be operated exclusively for religious, charitable, scientific, testing for public safety, literary or educational purposes and/or to foster national or international amateur sports competition (but it may foster national or international amateur sports competition only if no part of its activities involve the provision of athletic facilities or equipment), and/or for the prevention of cruelty to children or animals, no part of the net earnings of which shall inure to the benefit of any private shareholder or individual, no substantial part of the activities of which shall be carrying on political propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of Section 501 of the U.S. Internal Revenue Code) and which shall not participate in, or intervene in (including the publishing or distributing of political statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

Article 3

Incorporator, Agent and Address

The incorporator and initial registered agent of the Corporation is Toby Victor Olvera whose address is 2511 SW 35th Place #14 Gainesville, Florida 32608 which is both the address of the initial principal office of the corporation and the address of the initial registered office of the Corporation.

Article 4


Bylaws

The Corporation shall have bylaws. The bylaws shall specify the methods for amendment of the bylaws and for amendment of these Articles of Incorporation. The bylaws shall provide for the control of the Corporation by a board of directors. The method of election of directors shall be stated in the bylaws. The bylaws may also contain other provisions.

Article 5

Signature

The undersigned incorporator hereby promulgates the foregoing articles of incorporation and also, having been named as registered agent to accept service of process for the Corporation at the place designated above, affirms that he is familiar with, and accepts the appointment as registered agent and agrees to act in this capacity.
