

ARTICLES OF INCORPORATION

OF

THE INTERNATIONAL SWIMMING AND CULTURAL FOUNDATION, INC.

A NON-PROFIT CORPORATION

We, The undersigned incorporator(s), in order to form a non-profit corporation under the laws of the state of FLORIDA, adopt the following Articles of Incorporation:

ARTICLE ONE: NAME

The name of this corporation shall be

"THE INTERNATIONAL SWIMMING AND CULTURAL FOUNDATION, INC.". Its principal office shall be in the City of Pompano Beach, County of Broward, State of Florida.

ARTICLE TWO: PRINCIPAL OFFICE

The name and address of the registered agent of this corporation are:

ARTICLE THREE: PURPOSE

The specific purposes for which this corporation are the following:

A.To provide aquatic and cultural exchange between the United States and the entire World via work and services that help individuals in aquatic and cultural endeavors through their own activities and through other non-profit corporations, agencies, and/or professions, either domestic or foreign.

B.To provide financial assistance to swimming and cultural organizations, charities, agencies,or otherwise, or institutions affiliated with and acting in co-operation with any and all aquatic and cultural associations and their activities wherever located.

C. To promote the betterment of aquatics and culture through education, clinics, competitions, research, consultation, and exhibits, both directly and by the application of assets(i.e via grants) for the purposes and operations that are cultural, educational, or charitable.

D. The Corporation shall be empowered to publish papers, pamphlets, books and magazines, as the purposes of this Corporation, whether expressed or implied, shall require associate itself with other persons, corporate or natural, for the purposes of becoming a member of, and otherwise associating itself with other Corporations or associations of similar or like nature.

E. To be organized as to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Laws of the State of Florida.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE FOUR: MANNER OF ELECTION

Any person may become a member of the Corporation by the contribution of real and/or personal property for purposes of the Corporation and subscribing to the purposes of this Corporation.

At all meetings, except for the election of officers and directors, all votes shall be viva Voce. Election of officers, ballots shall be provided and there shall not appear any place on such ballot any mark or marking that might tend to indicate the person who cast such ballot. At all votes by ballot the chairman of such meeting shall immediately prior to the commencement of balloting appoint a committee of two who shall act as "Inspectors of Election" and who shall be at the conclusion of such balloting certify in writing to the Chairman the results and certified copy shall be physically affixed in the minute book to the minutes of that meeting.



ARTICLE EIGHT: ADDITIONAL PROVISIONS

: Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local Government, for a public purpose. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence Legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, Directors, officers, or other private persons, except that this corporation shall be

authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code. In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
