ARTICLES OF INCORPORATION

The undersigned persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

NAME

The name of this corporation is: Gainesville P'nai Or, Inc.

ARTICLE II

PURPOSE

The general nature of the objects and purposes of this corporation shall be:

1. To operate and maintain a religious, spiritual and educational organization;
2. To accept grants, gifts and bequests to support its purposes.

ARTICLE III

TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE IV

BOARD OF DIRECTORS

Section 1: The business affairs of this corporation shall be

managed by the Board of Directors. This corporation shall have three Directors initially. The number of Directors may be increased from time to time by the By-Laws, but shall never be less than three.

Section 2: The Board of Directors shall be members of the corporation.

Section 3: Members of the Board of Directors shall be elected and hold office in accordance with the By-Laws.

#### ARTICLE V

##### NON-PROFIT STATUS

Section 1: No part of the net earning of the corporation shall inure to the benefit of any individual or member.

Section 2: The corporation shall not carry on propaganda or otherwise act to influence legislation.

Section 3. Notwithstanding any other provisions of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE VI

##### POWERS

In order to promote the purposes of this corporation, it may acquire property by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the corporation shall require for the benefit of the members and nor for pecuniary profit.

## ARTICLE VII

### DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or local government, for a public purpose, and none of the assets will be distributed to any member, officer or trustee of this corporation.

## ARTICLE VIII

### INITIAL RESIDENT AGENT AND OFFICE

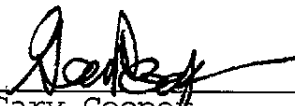

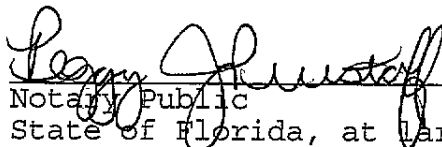
