The corporation has 2 officers:

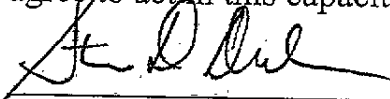

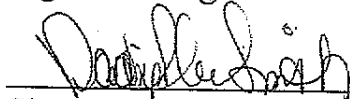

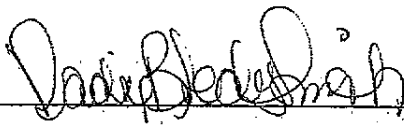
