Article VII: The name and address of the Incorporator is Mr. Robert J. Bellon, 3473 Ambassador Ave., Spring Hill, Fl. 34609.

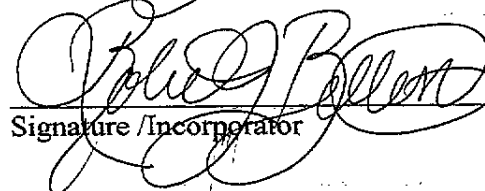
Article VIII: The effective date for the incorporation of these articles shall be no sooner than January 1, 2001.
