ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Afficies of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: The Professional Development Academy of Collier County, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 709 Third Avenue South, P.O. Box 9293, Naples, Florida 34101.

ARTICLE III PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any and all the things herein mentioned, as fully, and to the same extent as natural persons might or could do, and in any part of the world.

This is a non-stock, non-profit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the Florida Not for Profit Corporation Act. Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making and distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 to wit:

Establishing and operating a Professional Development Academy for the benefit of teachers and staff of the Collier County Public Schools and, for the training of employees of Collier County businesses.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

At the initial organizational meeting directors shall be elected by the incorporator and subsequently by a vote of all the membership at the annual meeting of the corporation in accordance with the By-Laws of the corporation.

ARTICLE V PROHIBITION OF DIVIDENDS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable as dividends or in any other manner, to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the

Articles of incorporation. Further, upon the dissolution of the corporation, the Board of Directors shall after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954(or the corresponding provisions of any future United States law) as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
