

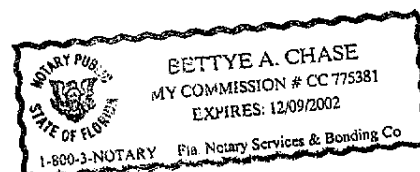

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the corporation shall be:

**ARTICLE III**

Purpose(s)

The specific purposes for which the corporation is organized are:

1. To preach the Gospel of Jesus Christ and conduct Christian religious worship services on a weekly basis.
2. To celebrate and perform weddings, baptisms, dedications of children, the sacrament of the Holy Communion and any other religious services admissible by law.
3. To conduct Bible and Theological studies, to educate, prepare, and train new leaders to serve in the different ministerial ranks at a local, national and

international level of our church and mission.

4. To offer spiritual support and counseling services to people with marriage, family, drugs and/or alcohol problems with the purpose of helping them to overcome their situations.
5. To provide emergency food and/or clothes to the homeless within the nearby community.
6. To conduct different recreational activities such as educational and spiritual retreats, sports, field trips, camping trips, picnics, hiking, and fishing for the members of our church.

## **ARTICLE IV**

### **Manner of election of directors.**

The method of election of directors shall be stated in the bylaws of this corporation.

## **ARTICLE V**

### **Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

The Asociacion Ministerial Evangelistica "La Voz Del Fin, Inc.", is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, church buildings, social halls, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
2. Collect, solicit, and accept funds, gifts, and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
3. Publish Christian news, conduct Bible studies, church services, perform all Christian religious services including the rites of marriage and baptism, as well as any other activities and programs of Christian nature admissible by law.
4. To appoint and ordain pastors to full and Holy Ministry, and to appoint Evangelists, Missionaries, Licensed Preachers and Chaplains to preach the Holy Gospel in all Jails, in all Hospitals, in according to the State laws.
5. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.
