

## ARTICLES OF INCORPORATION

of Ministries Inc. Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida

nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

Said HOME FRONT MINISTRIES is organized exclusively for religious purposes, within the meaning of section 501 (c) (3) of the Internal Revenue Code (or corresponding section).

Article VIII

**Article VIII** 

No part of the net earnings of HOME FRONT MINISTRIES shall inure to the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that HOME FRONT MINISTRIES shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes. No substantial part of the activities of HOME FRONT MINISTRIES shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and HOME FRONT MINISTRIES shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, HOME FRONT MINISTRIES shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

### Article IX

Upon dissolution of this HOME FRONT MINISTRIES, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious, or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

However, if named is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation, or corporation organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.
