***Articles of Incorporation
For
Ayuda Ministerio, Inc.***

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I: Name

The name of the corporation shall be Ayuda Ministerio, Inc.

ARTICLE II: Principal Office

The principal place of business of the corporation shall be 10415 Riverside Drive, Palm Beach Gardens, Florida 33410.

ARTICLE III: Purpose

The purpose for which the corporation is organized is to be a helps ministry to every nation, tribe and tongue—in their own language, by their own people—establishing schools, training centers, community development, local congregations and mission outreach according to the Gospel of Jesus Christ. The corporation is intended to be a religious not-for-profit organization and will seek tax exempt status from the Internal Revenue Service. The period of this corporation is perpetual unless dissolved according to law.


