The undersigned, acting as incorporators of a Corporation pursuant to Chapter
Florida Statutes, adopts the following Articles of Incorporation for

Article I

The name of the corporation shall be: **PUBLIC RADIO OF CENTRAL FLORIDA, INC.**

The principal place of business of this corporation shall be

11609 S.O.B.T, Ste 203, Orlando, FL 32837

Article II

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the date filed with the Department of State.

Article III

The purposes for which the corporation is organized are for Charitable, Educational, Literary, and Scientific purposes, including for such purposes as making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code of 1954, (or corresponding provision of any future United States Internal Revenue Law).

Article IV

The membership of this corporation shall constitute all persons hereinafter named as incorporators, and such others as, from time to time hereafter, may become members in a manner provided in the by-laws. A two-thirds vote of members present in any regular or special meeting called for in the manner provided in the by-laws, shall elect the membership an adult United States Citizen.

Article V

The number constituting the initial Board of Trustees of the corporation is , and the names and addresses of the persons who are to serve initially are. Trustees are elected as according to By-Laws.

Article VI

This corporation is organized under a non-stock basis.

Article VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local government for exclusive public purpose. Activities to comply with Internal Revenue Code. Not with standing any other provision of these Articles this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 the corresponding provision of any future United States Internal Revenue Law of (b) a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or other corresponding provision of any future United States Internal Revenue Law.

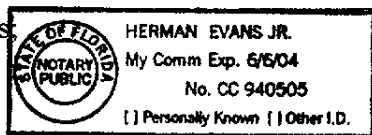

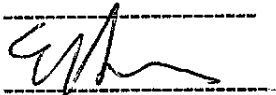
