**ARTICLE I**  
**NAME**

The name of the Corporation shall be identified as "Truths of the Word Evangelistic Team, Inc."

**ARTICLE II**  
**PRINCIPLE OFFICE**

The principal place of business shall be 10150 NW 38th Terrace, Chiefland, Florida 32626, and the mailing address of this corporation shall be Post Office Box 2237, Chiefland, Florida 32644.

**ARTICLE III**  
**PURPOSE**

This ministry shall consist of many facets of the Body of Christ, Jesus Christ. It shall be creatively led by the Holy Spirit through the Voice and Word of God rightly divided. The gifts of helps and giving both naturally and spiritually shall be stretched to the limits of God's imagination to minister to both the immediate and eternal needs of the people. We purpose to help people develop faith in God and faith in themselves by means of outreach ministry expressed through different talents, gifts and capacities.

Many of the services and works performed may be operated in conjunction with local churches, established ministries and organizations. **ARTICLE IV**  
**MANNER OF ELECTION**

The leading evangelist shall be called by God and may be of the male or female gender. The pronoun "he" shall be used as a collective generic term for the pronouns "he" or "she" when referring to the evangelist in this corporation.

The leading evangelist shall be the leader of the team and ultimate authority in all of its activities. He shall do the work of an evangelist, administer the ordinances, have charge of the stated ministries and also have charge of the direction of the evangelistic team as a whole. He shall serve in this capacity until death, resignation or until such time as 2/3 majority of the directors see necessity to appoint a new leader due to the current leader's corruption, slothfulness, ineffectiveness as a leader to put forth

the necessary effort and energy to accomplish the purpose, illness that affect his ability to make sound judgments, mishandling of the Word of God, or other such factors such as departing from the faith of Christ Jesus as described in the Bible that has rendered the leading evangelist incapable of continuing the necessary duties of this call according to the purpose in which this corporation was established.
