The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

Article I - Name

The name of the corporation shall be Knowing and Growing Learning Center, Inc.

Article II - Principle Office

The principal place of business and mailing address of this corporation shall be 1011 South Sanford Avenue, Sanford, Florida 32771.

Article III- Duration

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

Article IV - Purpose

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and purposes pursuant to the Florida Corporations Not for profit law set forth in Section 617 of the Florida Statues.

The specific purpose for which this corporation is organized is to improve the quality of life for children and their families in Sanford. To accomplish this purpose the Knowing and Growing Learning Center shall: a) offer child care for low income and at risk children; b) offer tutoring and enrichment programs for elementary school age children; and c) offer support and training for parents.

Article V - Board of Directors

The Knowing and Growing Learning Center, Incorporated, as a non-profit corporation, shall be managed by a Board of Directors, who shall be elected by the members of said Corporation annually. The qualifications of the members shall be such as the Board of Directors shall determine will work to the best interest of the Knowing and Growing Learning Center, Incorporated and shall become members of said corporation upon invitation of and acceptance by the said Board of Directors.
