The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

Article I - Name

The name of the corporation shall be Knowing and Growing Learning Center, Inc.

Article II - Principle Office

The principal place of business and mailing address of this corporation shall be 1011 South Sanford Avenue, Sanford, Florida 32771.

Article III- Duration

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

Article IV - Purpose

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and purposes pursuant to the Florida Corporations Not for profit law set forth in Section 617 of the Florida Statutes.

The specific purpose for which this corporation is organized is to improve the quality of life for children and their families in Sanford. To accomplish this purpose the Knowing and Growing Learning Center shall: a) offer child care for low income and at risk children; b) offer tutoring and enrichment programs for elementary school age children; and c) offer support and training for parents.

Article V - Board of Directors

The Knowing and Growing Learning Center, Incorporated, as a non-profit corporation, shall be managed by a Board of Directors, who shall be elected by the members of said Corporation annually. The qualifications of the members shall be such as the Board of Directors shall determine will work to the best interest of the Knowing and Growing Learning Center, Incorporated and shall become members of said corporation upon invitation of and acceptance by the said Board of Directors. The following name members shall constitute and be the Board of Directors, until the first regular meeting of the members thereof, at which time the Board of Directors for the succeeding year is elected, or until their successors are duly elected and qualified:

Article VII - By-Laws

The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors.

Article IX - Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon its Board of Directors is subject to this reservation.

Article X - Dissolution of the Corporation

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to another not-for-profit organization whose goals and purposes reflect those of the Knowing and Growing Learning Center. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


