Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit corporation, under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the corporation shall be BIBLEstudy.com, Inc.

Second: The place in this state where the principle office of the corporation is to be located is 1800 Atlantic Blvd., Key West, Monroe County, Florida. The Mailing address is P.O. Box 5430, Key West FL 33045,

Third: BIBLEstudy.com, Inc. is organized exclusively for, and will operate exclusively to advance the Christian religion, using the Internet to conduct interactive Bible study classes in order to spread the Gospel of Jesus Christ. At BIBLEstudy.com, volunteer ministers, pastors and Bible study leaders from numerous Christian churches around the country will be able to sign on as leaders after agreeing to the attached statement of faith, and conduct online, interactive Bible study classes over the web. The general public will be able to visit BIBLEstudy.com 24 hours a day, 7 days a week and study the Bible while simultaneously interacting with others studying the same chapter and verse. BIBLEstudy.com, Inc. will receive an estimated 90% plus of it's financial support from publicly supported organizations and the general public. Less than 10% of our financial support is expected to come from sales of BIBLEstudy.com branded items (i.e. T-shirts, hats, etc.) sold through our online store. BIBLEstudy.com, Inc. operates in compliance with the regulations put forth for exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The manner in which all future Directors and trustees shall be elected is as stated in the bylaws.

Fifth: No part of the net earnings of the corporation shall infire to the benefit, or be distributable to the members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the article third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf or opposition of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a

corporation, contributions to which are deductible under section 170(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not so disposed of shall be disposed of by a court of competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
