ARTICLES OF INCORPORATION for KALOGIANIS FOR CONGRESS, INC.

(A Florida Corporation Not For Profit)

The undersigned hereby associate themselves for the purpose of forming a Florida corporation not for profit pursuant to the laws of the State of Florida and Florida Not For Profit Corporation Act, Chapter 617, *Florida Statutes* (hereinafter, the "Act"), and certify as follows:

L NAME

The name of the Florida corporation not for profit shall be KALOGIANIS FOR CONGRESS, INC., (hereinafter referred to as the "Committee") having its initial principal office located at 4821 U.S. Highway 19, Suite 3, New Port Richey, Pasco County, Florida 34652, unless and until otherwise designated in writing to the Florida Department of State.

II. PURPOSE

The purpose for which the Committee is organized is to provide an entity, pursuant to Section 527 of the Internal Revenue Code, for the operation of a principal campaign committee designated as the KALOGIANIS FOR CONGRESS COMMITTEE, in Pasco County, Florida; for the purpose of supporting the candidacy of CHUCK KALOGIANIS to the U.S. House of Representatives (hereinafter, the "Candidate"), for the purpose of receiving and expending funds on behalf of said Candidate and for any other lawful purpose not inconsistent with the Act or with any other state or federal law.

The Committee shall make no distribution of income to its members, as defined in Article III hereof or to its directors or officers. The Committee shall have perpetual existence unless and until otherwise directed in writing to the Florida Department of State or by operation of law.

III. MEMBERS

The members of the Committee shall be as designated herein and declared by the Candidate. After termination of the Committee, members shall consist of those who were members of the terminated Committee at the time of such termination, their successors and assigns, and the Committee assets shall be disposed of in accordance with the provisions of the Federal Election Campaign Act. Committee membership shall be nontransferable.

After receiving approval from the Candidate, any change in membership shall be established by delivery of the Committee to the Department of State of a copy of such amendment as may be required pursuant to Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes. The new member(s) which are designated therein shall become member(s) of the Committee upon the filing of such amendment and the membership of any prior member(s) shall be terminated at such time. The Committee shall also notify the Florida Secretary of State and Federal Election Commission of such amendment as may be required pursuant to the provisions of the Federal Election Campaign Act (hereinafter, the "FEC").

IV. TERM

The term of the Committee shall be perpetual or, if the Committee is terminated, the term of the Committee shall end as soon thereafter as the affairs of the Committee can be winded down and concluded.

VIII. DIRECTORS

Board of Director members may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws of the Committee.

IX. BYLAWS

The first By-Laws of the Committee shall be adopted by the Board of Directors named herein and may be altered, amended, or added to at any time by the unanimous vote of all of the members of the Board until the first annual meeting of the Committee. Thereafter, the By-Laws may be altered, amended, or augmented at any duly noticed meeting of the Committee members and in accordance with the Committee By-Laws.

X. AMENDMENTS TO ARTICLES

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- A. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- B. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by members of the Committee. Board of Director members and Committee members not present in person or by proxy at the meeting considering the amendment may express their approval or disapproval in writing, provided such writing is delivered to the Secretary at or prior to the meeting.
- C. Proposed amendments will be passed upon approval of the members of the Committee, with the number of votes being cast at said meeting.
- D. Provided, however, that no amendment shall make any changes in the qualifications for membership, nor the voting rights of members, without approval in writing by all members.
- E. A copy of each amendment shall forwarded to and certified by the Florida Secretary of State. The Committee shall also notify the Florida Secretary of State and Federal Election Commission of such amendment as may be required pursuant to the provisions of the Federal Election Campaign Act.

XL POWERS

The powers of the Committee shall include and be governed by the following provisions:

- A. The Committee shall have all the powers of a corporation not for profit that are not in conflict with the terms of these Articles.
- B. The Committee shall have all the powers and duties set forth in the Act, and it shall have all of the powers and duties reasonably necessary to operate pursuant to the Committee By-laws as may be amended from time to time including, but not limited to, the following:
- 1. For the operation of a principal campaign committee designated as the KALOGIANIS FOR CONGRESS COMMITTEE, in Pasco County, Florida, and such other locations as may be designated from time to time;
- 2. For supporting the candidacy of CHUCK KALOGIANIS to the U.S. House of Representatives;
- 3. For fundraising, political advertising, campaign travel and for other legitimate campaign activities;
 - 4. For receiving and expending funds on behalf of said Candidate;
- 5. For the purpose of filing required FEC forms, campaign finance reports and other documentation as may be required by the Act, the Federal Campaign Elections Act and other applicable state and federal law;
 - 6. For approval or disapproval of contributions and expenditures;
- 7. For contracting for the management and operation of the Committee and to delegate all powers and duties of the Committee, except those specifically required to have the approval of the Candidate or the membership of the Committee;
- 8. For enforcement by legal means the provisions of the Act, these Articles and By-Laws of the Committee; to sue for damages caused by third-parties to the Candidate or to the Committee; to sue or be sued;
- 9. For employing personnel to perform the services required for the proper management and operation of the Committee;
- 10. For purchasing assets for reasonable use by the Committee in effectuating its purposes, with the expenses incurred in the maintenance and operation of same to be an expense of the Committee;
- 11. To open campaign depositories, purchase insurance, invest campaign funds in a manner authorized by law or obtain loans in a manner authorized by law;
- 12. For any other lawful purpose not inconsistent with the Act, the Federal Election Campaign Act and other local, county, state or federal law.

XII. INDEMNIFICATION

The Committee shall indemnify every member of the Board of Directors and every officer, his heirs, personal representatives and assigns against all losses, costs and expenses reasonably incurred by him in connection with any action, suit or proceeding to which he may be a party by reason of his being or having been a Director or Officer of the Committee, including reasonable attorney's fees and costs, including those on appeal, except as to matters wherein he shall be finally adjudged in such action, suit or proceeding to be liable for or guilty of gross negligence or willful misconduct. The foregoing rights shall be in addition to, and not exclusive of, all other rights to which such Director or Officer may be entitled. The Board may, as and when available, obtain officers' and directors' liability insurance and the cost of same shall be deemed an expense of the Committee.

XIII REGISTERED AGENT

The Registered Agent to accept service of process within this State for said corporation shall be CHUCK KALOGIANIS and the registered office of the corporation shall be at 4821 U.S. Highway 19, Suite 3, New Port Richey, Pasco County, Florida 34652.
