# ARTICLES OF INCORPORATION OF TAMPA TIGERS YOUTH BASEBALL FOUNDATION, INC.

The undersigned, for the purpose of forming a nonprofit corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

## ARTICLE ONE Name

1.1 The name of the corporation is Tampa Tigers Youth Baseball Foundation, Inc.

#### ARTICLE TWO Duration

2.1 The term of existence of the corporation is perpetual.

## ARTICLE THREE Purpose

3.1 The purpose for which the corporation is organized is to promote positive social and athletic principles in minors through participation in youth baseball.

## ARTICLE FOUR Manner of Election of Directors

4.1 Directors will be elected by a majority vote of the Board of Directors.

#### ARTICLE FIVE Principal and Registered Offices

By signing these Articles of Incorporation, the registered agent accepts the designation and agrees to comply with all provisions of the Florida Statutes relating to that designation, including keeping the registered office open during the appointed hours of operation.
