## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617.F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of the corporation shall be: *New Day Children's Services, Inc.*

### **ARTICLE II PRINCIPAL OFFICE**

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- 1. To provide economic assistance to families in Gadsden County, Florida, in the form of food, clothing household needs, information on community services for economic assistance, and job readiness skills and job search.*
- 2. To provide academic services to foster children and community children of Gadsden County, Florida, including after-school tutoring, completion of educational goals including GED preparation, computer training, job preparation and assistance in locating and maintaining employment.*
- 3. General support will be provided to foster children in Independent Living status in the form of assistance with job search and job readiness, GED readiness preparation, information on community vocational/technical services and transportation services relating these activities.*

*This corporation is organized exclusively, for one or more of the purposes specified in section 501(c)(3) of the Internal Revenue Code, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue code, or corresponding section of any future federal tax code.*

### **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

*Directors shall be appointed in the manner and for the terms provided in the bylaws. The board will not consist of fewer than 3 directors with a minimum term of service not to be less than 1 year.*
