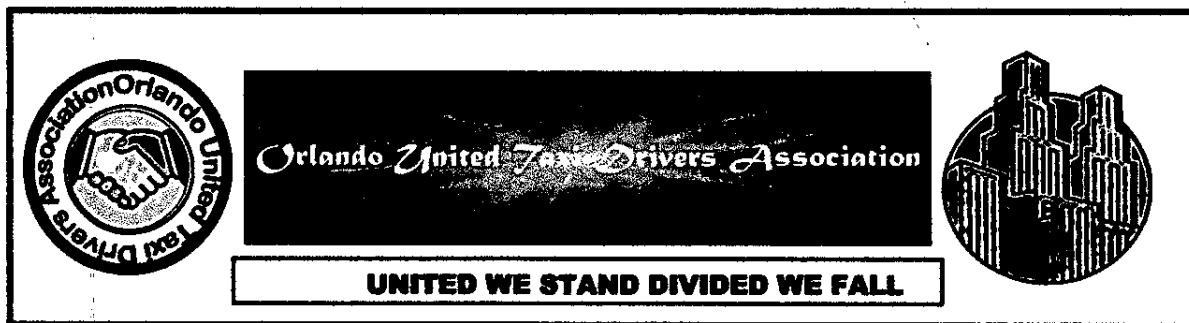

elect a new President for the upcoming term.

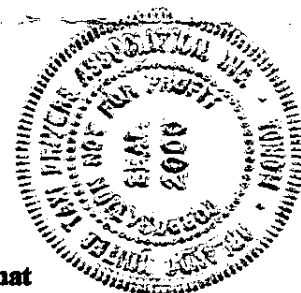
The chairperson then elected as acting secretary Mrs. Angeoleter Brown
