**ARTICLES OF INCORPORATION
OF
ABUNDANT LIFE MINISTRY OF CENTRAL FLORIDA, INC.**

- ONE:** The name and address of this principal corporation is Abundant Life Ministry of Central Florida, Inc. Located at 3807 Grove View Lane Port Orange, Florida 32119. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO:** This corporation is non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Religious Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church) in accordance with the Doctrine of the corporation creed/by-laws to spread the gospel of Jesus Christ. The religious program will consist of Media Ministry, Economic Development Programs, but, shall not be limited to: Homeless, Health Care, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.



EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for Religious under Section 501(c)(3) of The Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
