**ARTICLES OF INCORPORATION:** The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME:**

The name of this organization shall be: The National Accessible Travel Specialists Association, Inc.

**ARTICLE II: PRINCIPAL OFFICE:**

The principal place of business and mailing address of this corporation shall be: National Accessible Travel Specialists Association, Inc., 7858 Havana Highway, Havana, Florida 32333.

**ARTICLE III: PURPOSE:**

The National Accessible Travel Specialists Association, Inc., is organized as an education training facility to develop and implement a specialized program for enabling sellers of travel and persons with disabilities to learn the necessary information about arranging travel for persons with all sorts of disabilities, regardless of race, religion, sex, national origin, age, economic capability or disability. It is especially geared towards students to assist them in improving their skills using technology of the future and the internet. The goal is to create an atmosphere of learning and utilization of the internet to encourage students to meet their potential of knowing and understand the needs and limitations of the disabled traveler. They must learn to provide the same level of travel enjoyment for persons with disabilities as do travelers who have no disabilities.

**ARTICLE IV: MANNER OF ELECTION OF DIRECTORS & LEGAL STATUS:**

Directors are elected to the Board of Directors and Officers chosen at the annual membership meeting held each year through a nominating and election process. Membership in the organization shall be open to any individual, organization, family or corporation who want to become travel agents specializing in arranging travel for persons with disabilities and their families. Non-members may participate in advising on the utilization of technical equipment and also volunteer their services to assist the students in learning to become more competitive in the new world of technology and providing expertise in arranging travel for persons with disabilities and with physical and mental limitations.. Non-members may not vote at its business meetings, hold office or be members of standing committees. All members may participate in all activities without

regard to race, sex, national origin or religion, economic capability or disability. Membership dues shall be set by the Board of Directors. An Education Advisory Council consisting of 15 members from various organizations representing those with limitations and disabilities shall serve as a resource for the organization.

The National Accessible Travel Specialists Association, Inc. shall be a tax-exempt organization under the terms of Section 501(c)(3) of the United States Internal Revenue Code of 1954 ( or any corresponding provision of any future Internal Revenue Code) It is organized for the pursuit of education and technology training for students who wish to become experts in the field of arranging Accessible Travel for persons with disabilities and any monies generated through the efforts of this group shall not inure to the benefit of its members, trustees, officers or any other private persons.
