## ARTICLES OF INCORPORATION

### FOR

**MINISTERIO CRISTIANO LA ROCA, INC.** (THE ROCK CHRISTIAN MINISTRY, INC.)

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### ARTICLE 1: NAME

The name of the corporation shall be:

**MINISTERIO CRISTIANO LA ROCA, INC.**

**(THE ROCK CHRISTIAN MINISTRY, INC.)**

in affiliation with the **Pentecostal Free Will Baptist Church, Inc.** with headquarters in Dunn, North Carolina, USA.

#### ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

#### ARTICLE III: PURPOSES

The specific purposes for which the corporation is organized are:

1. To proclaim the Gospel of Jesus Christ as the true alternative for salvation and true freedom for the soul, the mind and the spirit.
2. To provide religious and educational services through: family groups, evangelism, religious education, support groups, world and local missions.
3. To provide community services such as: food and clothing banks for the poor and the homeless, etc. as means becomes available.
4. To provide religious help services.
5. To provide healthy recreational and social activities, such as: Youth programs, Senior citizens, family retreats, couples retreats, etc.
6. To participate in local and international relief efforts when means becomes available.

#### ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

The Founders and the Pastor/Chair and Original Incorporators have the power to appoint non-elected

local church officers, with such power vested on the Chair to confirm or reject elected or non-elected officers. The directors or officers, except the Chair/Senior Pastor, are elected by the vote of the congregation as established by the constitution and by-laws. Elders and/or Trustees are appointed by the Chair and sanctioned by the congregation.

#### **ARTICLE V: LIMITATION OF CORPORATE POWERS**

Corporate powers as provided by the Florida Statutes, Section 617.0302 and as provided by the Constitution and By-laws of the corporation. Individuals that do not conform with the values and principles described in the constitution and by-laws of the corporation, will not be able to be appointed either by vote or by appointment.

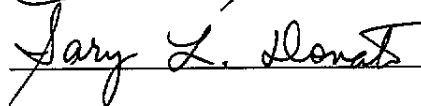
