**FIRST: Amendment adopted for Article II**

For purposes of this resolution, "interested persons" means either:



**FOURTH:** The date of adoption of the amendment was: June 29, 2001.


**FIFTH:** Adoption of Amendment: The amendment was adopted by the former board of directors and present board of directors.




