Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I

The Name of the Corporation shall be New Life Community Church of Lakeland, Inc.
The period of duration of this Corporation is Perpetual unless dissolved according to law.

Article II

The principal place of business and mailing address of this corporation shall be 5015 South Florida Avenue, Suite 404, Lakeland, FL 33813.

Article III

The purposes for which the Corporation is organized are as follows:

1. To preach the gospel of Jesus Christ as revealed in the Holy Scriptures and provide religious education and training for its members and those attending church meetings..
2. To employ and discharge commissioned ministers of the Gospel, and others, to conduct and carry on divine services at a place of worship, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said corporation.
3. To acquire property whether real, personal or mixed, by purchase, gift, legacy, bequest or in any manner and to borrow money, issue bonds or notes, and all other documents necessary or appropriate in carrying out the objects and purposes set forth in this Article III.
4. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes of the attainment of any one or more of the purposes herein stated, or incidental to the powers named, or which shall at any time appear conducive or expedient for the promotion of its welfare, and accomplishment of the purposes herein stated.

The manner in which the directors are elected or appointed is by a congregational nomination and pastoral appointment.
