- ONE: The name of the corporation shall be: Dress for Success Palm Beach County, Inc.
- TWO: The principal place of business and mailing address of this corporation shall be 1435 10<sup>th</sup> Street, Lake Park, Florida 33403 in Palm Beach County Florida. The corporation is organized pursuant to the Florida Non-profit Corporation Code.
- THREE: This corporation is a not-for-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law, for charitable and educational purposes to help low-income and disadvantaged women make successful transitions into the workforce. The programs will consist the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Providing business appropriate suits, clothing and accessories to low-income women for job interviews and then once they obtain employment; Seminars and One on One Consultations related to interview and job preparation, as well as, and job maintenance; and Outreach Advocacy.
- FOUR: The directors are elected in accordance with the By-Laws. The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

(b) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activity not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

NINE: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for, Charitable and Educational Purposes under Section 501 (c)(3) of the Internal Revenue Code.

TEN: The liability of the directors of this corporation for monetary damages shall be eliminated to the fullest extent permissible under Florida law.
