**ARTICLES OF INCORPORATION
OF
IGLESIA PENTECOSTAL UNA MIRANDA de FE', INC.
(A Florida Nonprofit Corporation)**

We, the undersigned, desiring to associate for the purpose of forming a corporation not for profit under the provisions of Chapter 617, Florida Statutes, do hereby agree to the following:

ARTICLE I - NAME AND LOCATION

The name of this corporation of **IGLESIA PENTECOSTAL UNA MIRANDA de FE', INC.**, of 4692 Hoffner Avenue, Orlando, Florida, 32812.

ARTICLE II - PURPOSES

This is a nonprofit corporation organized for the purpose of advancing the Christian faith and the gospel of Jesus Christ and saving souls and to conduct all lawful business not for pecuniary profit and not specifically prohibited to corporations under the laws of Florida.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

ARTICLE IV - NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 4692 Hoffner Avenue, Orlando, Florida, 32812, and the name of the initial registered agent of this corporation is **LUIS J. PEREZ**.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be increased from time to time, but shall never be less than three (3). The method of election of the directors shall be in the manner as set forth in the Bylaws. The names and addresses of the initial directors of this corporation are:

ARTICLE VIII - MEMBERSHIP

The qualification of members and the manner of their admission shall be determined by the Bylaws of this corporation, but notwithstanding any provisions in the Bylaws, all persons

to be qualified as members hereof shall have professed Christ and have been baptized according to the teachings of the Word of God, the Bible, and shall be admitted only upon the profession of faith in Christ, the baptism as aforesaid, and on a majority vote of those members present and voting at any regular church meeting.

ARTICLE IX - AMENDMENT

The Bylaws and Articles of Incorporation shall be made, altered, amended or rescinded by a majority vote of the members of this corporation present and voting at a regular, annual or special meeting called for that purpose.

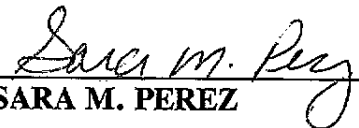
ARTICLE X - DISSOLUTION

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which are qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a state or local government, for a public purpose, none of the assets shall be distributed to any member, officer or trustee of this corporation. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue laws, or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954, or any other corresponding provisions of any future United States Internal Revenue Law, and in addition,

notwithstanding any other provisions of these articles, this corporation is formed exclusively for charitable and educational purposes.

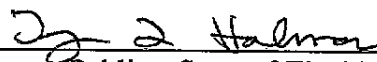
