**ARTICLES OF INCORPORATION**  
**of**  
**Ancient Traditional Chinese Medical Association, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act in compliance with Chapter 617, F.S., hereby adopts the following Articles of Incorporation:

**ARTICLE I, NAME**

The name of the corporation shall be Ancient Traditional Chinese Medical Association, Inc.

**ARTICLE II, PRINCIPAL OFFICE**

The Corporation's initial business address is 3149 North Courtenay Parkway, Merritt Island, Florida 32953.

**ARTICLE III, PURPOSE**

This corporation is organized as a 501(c)(3) organization as defined in the Internal Revenue Code for the exclusive purpose of providing medical services to the needy and educating the public about Traditional Chinese medicine.

**ARTICLE IV, MANNER OF ELECTION OF DIRECTORS**

The manner in which the officers and board of directors are elected is contained in the bylaws of the Association. Elections will be held annually at the December meeting. Each member is allowed one vote. The member's will elect the directors based on a majority, anything over 50%, vote.

**ARTICLE V, REGISTERED AGENT**

The name and address of the initial registered agent of the corporation shall be Hai Sha Ni, 3149 North Courtenay Parkway, Merritt Island, Florida 32953.


**ARTICLE V, TERM OF EXISTANCE**
