CORETARY OF STATE ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION MIAMI HILLEL FOUNDATION, INC.

Pursuant to the provisions of Chapter 617, Florida Statutes, MIAMI HILLEL FOUNDATION, INC., a Florida not for profit corporation (the "Corporation"), adopts the following articles of amendment to its certificate of re-incorporation and reinstatement which was filed with the Florida Department of State on January 26, 2001, Charter Number N01000000636.

FIRST: Article I of the Certificate of Reinstatement and Re-incorporation of this Corporation is amended to read in its entirety as follows:

#### Article I Corporation Name

The name of the corporation shall be: Greater Miami Hillel Foundation, Inc.
