### Article One                      Name

### ARTICLE Three                      Purpose

The purpose for which the corporation is organized is:

To operate exclusively for religious, charitable, educational, church, and distinct Ecclesiastical purposes within the meaning of section 501 ( c ) ( 3 ) of the Internal revenue code of now or any superceding statue thereto, and such purposes shall include the following,

- a) Religious
- b) To conduct a local church by the direction of our Lord Jesus Christ and under the leadership of the Holy Spirt in accordance with all of the commandments and provisions set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:
  - 1) A recognized Creed, Code of Doctrine, disciplined and form of worship shall be established.
  - 2) An ecclesiastical form of government shall be established.
  - 3) Ordination of ministers upon completion of prescribed course of study , designated by this church minister.
  - 4) An organization of ministers shall be established to minister to the congregation.
  - 5) Establishment of a church membership based upon acceptance of a recognized creed and belief and support of Church.
  - 6) Spread the Word of the Gospel through seminars, radio, television, establishment of Church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
  - 7) Establishment of various religious services pursuant to the recognized Creed, forms of worship, code of doctrine and discipline of the Church and the establishment of Sunday Schools and religious Schools for Christians and educational instructions to the young and to the old.

  - e) To acquire and hold such property, either real or personal for the Church purpose, as may be necessary for its membership and worship of God.
