### ARTICLES OF INCORPORATION

### AL-ANSAR GROUP, INC.

The undersigned, pursuant to chapter 617, Florida Statutes, and for the purpose of forming a corporation not for profit, adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be AL-ANSAR GROUP, INC.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business shall be 7304 Royal Oak Drive, Spring Hill, FL 34607 and the mailing address of the corporation shall be 7304 Royal Oak Drive, Spring Hill, FL 34607.

## ARTICLE III - PURPOSES

The Corporation is organized exclusively for the following:

A. Charitable, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.) and the Regulations thereof.

#### ARTICLE IV - INITIAL BOARD OF DIRECTORS

This corporation shall have three Directors constituting the initial Board of Directors.

The number of Directors may be either increased or decreased from time to time in accordance with the By-Laws but shall never be less than three. ## ARTICLE V - MEMBERS

The authorized number and qualification of members of the corporation, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability to dues or assessments and the method of collection thereof, shall be set forth in the bylaws.

#### ARTICLE VI - DISTRIBUTION OF GAINS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, or officers, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda in, or intervene in (including the publishing of distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office.

## ARTICLE VII - PERMITTED SERVICES

Notwithstanding any other provision of these articles, the corporation shall not carry on any other services not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

## ARTICLE VIII - DISSOLUTION

In the event of the dissolution and winding up of this corporation, after paying or adequately providing for the debts or obligations of this corporation, the directors, or persons in charge of liquidation, shall grant, convey, assign and transfer the remaining assets of this Fax Audit Number H01000012136 7

- (1) A state, a territory, a possession of the United States, or any political subdivision of any of the foregoing; or to the United States or the District of Columbia, to be used exclusively for public purposes, or
  - (2) A corporation, trust, or community chest, fund or foundation:
- (a) Created or organized in the United States or in any possession thereof, or under the law of the United States, any state or territory, the District of Columbia, or any possession of the United States.
- (b) Organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children or animals;
- (c) No part of the net earnings of which inures to the benefit of any private shareholder or individual; and
- (d) No substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

The assets transferred to any organization listed above shall be used within the United States, or any of its possessions, exclusively for the purposes specified in subparagraph (b).

No such organization listed above shall qualify for distribution unless such organization shall be an organization, association, fund or foundation organized and operated exclusively for charitable, religious, scientific or educational purposes which is tax-exempt, non-profit corporation under the United States Internal Revenue Code, and which is recognized as such by the United States Bureau of Internal Revenue.

If the corporation holds any assets in trust at the time of dissolution thereof, such assets shall be disposed of in such manner as may be directed by decree of the circuit court in the county in which the dissolved corporation had its principal office, upon petition
