I spoke to an operator on 04/21/2005 in reference to reinstatement of the Heartland Pentecostal Church Corporation.

I explained that we have never received our initial corporation papers from the State of Florida, because of an improper mailing address and I wanted to file a reinstatement. The operator (Margarita, I believe) said that the reinstatement fee, could be waived, but we needed to pay \$245.00 for the past yearly registration fees.


