



# NOT FOR PROFIT ARTICLES OF INCORPORATION

OF



# IGLESIA BAUTISTA CALVARIA, INC.

The undersigned subscribers to these Not for Profit Articles of Incorporation, natural persons competent to contract, hereby form a corporation not for profit under the laws of the State of Florida.

# <u>ARTICLE I - NAME</u>

The name of the corporation is IGLESIA BAUTISTA CALVARIA, INC.

# <u>ARTICLE II - NATURE OF BUSINESS</u>

The general character, purpose, and nature of business to be transacted by this corporation is as follows:

- (a) To operate exclusively for religious, charitable, literary and/or educational purposes.
- (b) To foster the religious doctrine through local and foreign ministries.
- (c) No part of the net earnings will inure to the benefit of the corporation, its officers, and/or its directors, or private shareholders or individuals, as applicable.
- (d) No part of the net earnings will inure to the benefit of influencing legislation or any political campaign on behalf of any candidate for public office.
  - (e) To carry on in any capacity any business or trade deemed legal in the State of Florida.
- (f) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.
- (g) To hold assets and/or purchase the corporate assets of any other corporation and engage in the same or other character of business which shall be designated for its exempt purpose.
- (h) To become a partner with any person or persons, corporation or any other business entity and engage in the same or other or any character of business legal in the State of Florida.
- (i) To enter into, make, perform and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any firm, association or corporation; and to

transact any further and other business necessarily connected with the purposes of this corporation, or calculated to facilitate the same.

- (j) To carry on any or all of its operations and business, and to promote its objects within the State of Florida or elsewhere, without restrictions as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.
- (k) To do any or all of the things herein set forth to the same extent as natural persons might or could do; and in any part of the world as principals, agents, contractors or otherwise, alone or in company with others, and to do and perform all such things and acts as may be necessary, non-profitable and expedient in carrying on any of the business or acts above named.

The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in this Article, shall be in anywise limited or restricted by reference to or inference from the terms of any other objects, powers, or clause of this Article or any other Articles; but that the objects and powers specifies in each of the clauses and in this Articles shall be regarded as independent objects and powers.

# **ARTICLE V - TERM OF EXISTENCE**

This corporation shall have perpetual existence.

# **ARTICLE VI - ADDRESS**

The initial street address of the principal office of this corporation is to be at 6709 St. Augustine Rd., #152, Jacksonville, Florida 32217. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

# **ARTICLE VII - RESIDENT AGENT**
