**ARTICLE I - NAME AND ADDRESS**

The name of the corporation shall be *Primitive Haitian Baptist Church, Inc.* with its place of business at 711 East Chatelaine Blvd., Delray Beach, Florida 33445.

**ARTICLE II - CORPORATE NATURE**

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

**ARTICLE III - PURPOSE**

#### **ARTICLE XI DISSOLUTION**

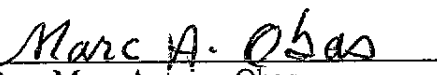
