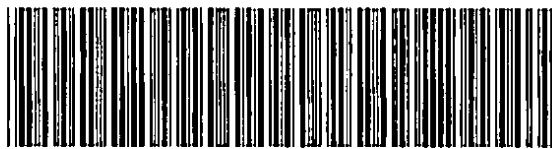

Article 2.2 Numbers and Powers The management of all the affairs, property, and interests of the Corporation shall be vested in the Board of Directors, consisting of not less than three (3) to a maximum of seven (7) Board members. The Corporation's Board of Directors shall consist of at least (1/3) representation that can include residents of the targeted areas served, low income persons and/or representatives of an organization that serves primarily low income persons. Board members shall serve until their term expires, they are removed, or resign from the Board. In addition to the powers and authorities

expressly conferred by these By-Laws and Articles of Incorporation, the Board of Directors may exercise all such powers of t

Article 3.4 Number of Meetings The Corporation shall meet a minimum of five (5) times a year one quarterly meeting
and an annual gathering - and shall be authorized to adopt, amend and repeal rules of the organization and procedures for the
conduct of its business; provided, however, such rules of organization and procedures shall not deviate substantially from the
Articles and By-Laws of the Corporation.


