

# ARTICLES OF INCORPORATION

#### FAMILIAS EN ESTADO DE CRISIS INC.

Incorporation stated below and files with the State Department of Florida, these Articles of Incorporation with the purpose of forming a Non Profit Foundation under the laws of the State Of Florida.

#### ARTICLE I

#### Name

The name of this Foundation shall be known as Familias en Estado de Crisis Inc. (Families in State of Crisis).

# **ARTICLES II**

# Principal Office | Terms of Existence

The physical address shall be 2545 Logandale Dr. Orlando, Fl 32817, but may establish openly this Foundation in different states throughout the United States by the Familias en Estado de Crisis Inc. main office in the State of Florida. This Foundation will have a Perpetual Existence.

# ARTICLE III

# Purpose(s)

The purposes for which the Fundacion Familias en Estado de Crisis Inc. is organizing are the following:

- 1. This Foundation will have programs for families or single individuals, and they are the following:
  - Family Help Program
  - Family Support Program
  - Economic and | or Financial help on various family bills.

- Family interest orientation
- Family Health
- Family food and clothing Program
- This Foundation will assist Hispanics or Americans in general..
- This Foundation will have different activities for collecting funds.
- This Foundation will take contact with different Government Agencies for send us refers.

We shall be adding more help programs not mentioned at this moment in the Article.

#### **ARTICLE IV**

#### **Board of Directors**

The names and addresses of the incorporators shall be the initial directors of the Foundation with have incumbents permanent, who are subject to these articles of incorporation and the laws of the State of Florida. This initial Board will work to complete the Statutes that shall govern the destination of the Foundation including the regulations. The Board of Directors is composed of the following:

- Director
- Sub-Director
- Secretary
- Finance Director
- Discipline Director
- Commissions Director
- Director of United Country to the Foundation
- Vocals (3)
- Incumbents Permanent Commissions (Incorporators)

Our Foundation shall not and will not discriminate by race, color, sex, politics, religion or social condition. The proposed form of selection of the new Board of Directors is as follows: The Foundation will work with different Commissions- some shall be incumbents permanent (Incorporators) and others transitional named by the Director in accordance of the needs. Each commission will have its Director and team of work. The Director will be responsible of his or her commission. These Directors are the ones that may aspire for the election to the Board of Directors; or the incumbent may be re-elected to his/her same position or a new one. The incumbent's term of eligibility is 4 (four) years. The General Director, once fulfilled his or her term, will be given a position of advisor. If necessary the Board of Directors has the right and faculty to replace any person of the Foundation for disciplinary actions. The punishment or suspension shall not be for more than one (1) month. This term will be discussed as we work with our regulations.

# Initial Registration of the Official Agent
